ADOPTION (AMENDMENT) RULES 2009

Laid before Tynwald16th June 2009Coming into operation1st September 2009

The Deemsters make these Rules under section 52 of the Adoption Act 1984¹.

1. Citation and commencement

- (1) The title of these Rules is the Adoption (Amendment) Rules 2009.
- (2) These Rules shall come into operation on the 1st September 2009.

2. Amendment of 2003 Rules

- (1) The Adoption Rules 2003² are amended as follows:
- (2) In rule 1(2), in the definition of "Rules of the High Court", for "1952" substitute "2009".
- (3) In rule 2, at the end insert
 - "(4) Without prejudice to paragraph (2)
 - (a) the Rules of the High Court apply to an originating application under these Rules as they apply to a claim or claim form;
 - (b) in relation to proceedings to which these Rules apply, references in the Rules of the High Court to a claimant or defendant shall be construed as references to an applicant or respondent respectively."

(4) In rule 19 —

- (a) in paragraph (1), for "petition" (in the first place) substitute "originating application";
- (b) for "petition" (wherever else occurring) substitute "application"
- (c) for "petitioner" (wherever occurring) substitute "applicant";

- (d) in paragraph (6), for "Order 51F of the Rules of the High Court" substitute "Part 6 of the Rules of the High Court (Family Proceedings) 2009^3 ".
- (5) In rules 28(2) and 29(2)(b), for "petition" substitute "originating application".
- (6) In Schedule 1
 - (a) in form 1, for the heading substitute —

"IN THE HIGH COURT OF JUSTICE OF THE ISLE OF MAN

(b) in form 4, for the words from the beginning to "1984" substitute —
