

ALTERNATIVE PAYMENT METHODS

Are you aware that there are several alternative methods of making payments rather than attending the Public Counter of the Isle of Man Courts of Justice?

Payments of Fines, Maintenance, Fixed Penalty, Legal Aid and Court Fees

- BACS
- Telephone Payments
- Online Services (Fixed Penalties only)
- Postal Payments
- Standing Orders (Fines and Maintenance only)

To make a payment via BACS:

IT IS ESSENTIAL THAT THE REFERENCE QUOTED CONTAINS THE COURT REFERENCE, FOR EXAMPLE STARTING WITH SC [fine] or MA [maintenance] AND YOUR SURNAME OR, IF APPLICABLE, THE SERVICE BEING PAID FOR, AND PAYER NAME.

If no reference number is supplied, this may result in a delay to the payment being allocated.

If you are making more than one payment, please make them on <u>separate</u> transactions.

PLEASE BE AWARE: There are two online payment sites, at the above address which are:

- <u>Fixed Penalty Notice</u> This site is for payment of parking tickets issued by the Department of Infrastructure, or the Isle of Man Constabulary, processed via the Isle of Man Courts.
- <u>Excess Car Parking Charge</u> This site is for payment of parking tickets issued in the Tongue, Battery Pier and Parade Street car parks and is **NOT** dealt with by the Isle of Man Courts.
- There is also a link to the Douglas Borough Council payment site regarding the Bottleneck, Chester Street, Drumgold Street (Marks & Spencer), Pulrose Road and Shaw's Brow car parks.
