Interpretation Act 2015

GENERAL REGISTRY (MISCELLANEOUS FEES) ORDER 2023

Laid before Tynwald:

Coming into Operation: in accordance with article 2

The Treasury makes the following Order under section 81 of the Interpretation Act 2015.

1 Title

This Order is the General Registry (Miscellaneous Fees) Order 2023.

2 Commencement

This Order comes into operation on the day it is made.¹

3 Miscellaneous fees in the General Registry

- (1) For each matter described in the 2nd column of the table in the Schedule the fee set out in the corresponding row in the 3rd column is payable.
- (2) All fees are outside the scope of Value Added Tax (“VAT”) unless shown otherwise in the 4th column of the table in the Schedule.
- (3) Where a fee is subject to VAT, this is at the standard rate (“Std.”).

4 Revocation

The General Registry (Miscellaneous Fees) Order 2021² is revoked.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order, made under the Interpretation Act 2015, revokes and replaces the General Registry (Miscellaneous Fees) Order [SD 2021/0094].

The collection of fees for the supply of a copy of the Isle of Man Electoral Register to an individual or a credit reference agency, previously included in this Order, has been removed subsequent to the transfer of this function from the Chief Registrar of the General Registry to the Registrar General of the Central Registry as a result of the Registration of Electors Regulations 2021 [SD 2021/0218].

All fees were increased by 5% (with an element of rounding) in line with general budget assumptions for income collected in 2023/24.
